Elected and Appointed Officials and Staff: Supervisor Dan Storck, Mount Vernon District; Nick Rinehart, Mount Vernon County Staff

The meeting was called to order at 7:02 PM

March 2024 minutes - Minutes approved unanimously.

TREASURER REPORT: The Treasurers report, as published in the March Record, was unanimously accepted. Has a new budget for next fiscal year and looks about the same as this year. FY 24-25 budget will be presented at 22 May GC meeting.

EDU - Judy reported for Kathy - did not meet this month and are waiting to see what the Commonwealth will do for additional funding for schools; sensing more of a positive attitude about potentially re-boundarying and will see how that works out.

ER - Focus of the meeting was climate resilience guidance that the state is issuing; discussion about Fairfax County issuing guidance about climate resilience and updating Chesapeake Bay ordinance; two resolutions - one for Fairfax County and one for Virginia; discussion about invasives in Collingwood Park and GW Parkway. Please see other details in the record.

PZ - Property attorney for IMP building attended meeting. Planning to build garden style apartments; developer is asking MVCCA if we can help them to suggest to the county to move SPCCA to from tier 3 to tier 1; second speaker spoke to group about the existing zoning ordinance about type of vehicles stored on sites; C8 District - most of Route 1 is C8; make special exception process to increase outdoor storage and light vs heavy equipment; not going to allow people to store equipment on their front lawns

Co-chair - Reminder for environmental expo was given. The Friends of Dyke Marsh asked the MVCCA to cosign a letter to the National Park Service asking them to install freeze free water fountains along the bike path from National Airport to MV Estate. A request for a vote was made and the measure was unanimously approved.

TRANS - Short meeting about resolution that will be presenting to MVCCA; FYI that Richmond HWY 495 to Hybla Valley; Fort Hunt Road from Richmond Hwy to Belle View and a section of Old Mt Vernon Rd:

Stormwater - Did not meet - waiting for policy to come out and the Grant program to be announced.

Nominating Committee - have some recommendations to the General Council for open positions and will be in the May Record.

SFDC - Reindeer Sculpture done by Fabian Lagos who lives here in Mt Zephyr; looking for other grants to add art to Richmond Hwy Corridor to make it more of an art corridor; working with Michael Alfano (https://www.michaelalfano.com/). Best Way on Richmond Hwy has closed, and the owner is looking to either lease or sell.

Meeting participants included: Wellington Civic Association, Hollin Hall Village Citizens, Association, Spring Bank Community Association, Huntington Community Association, And Belle Haven Condominium Unit Owners Association.

The committee considered a resolution on Collingwood Park and decided that we should collect more information before adopting the resolution. Mount Vernon Park Commissioner made it clear that the issue of invasive plants that we are seeing in Collingwood are also seen in other parks and that funding is a major constraint.

The committee also discussed a memorandum that was signed by the County Executive on funding needs for flooding. While the committee recognizes the need for this funding, we agreed that we wanted to hear from the Stormwater Committee before taking a position.

A motion to adjourn the meeting was made by Ellen Young and seconded by Dorothy Keough. The motion passed unanimously and the meeting adjourned at 8:15 pm.

Proceedings:

Linda Hollis, the Ford Family Chronicler for the West Ford Legacy Foundation, provided a presentation about the West Ford Legacy Foundation and the proposed mural that the Foundation wants to paint on one of the water tanks on Fordson Road. The West Ford family inherited land from Washington's estate that later became Gums Spring. The foundation was established 30 years ago to bring Ford decedents together, preserve the Ford legacy, and conduct genealogy research. The foundation also promotes and funds related outreach such as the mural project.

The Foundation and community members will meet with Mount Vernon Supervisor on May 24th to discuss the project. They plan to develop a project plan and solicit sample mural designs. They will also identify project costs and prepare a funding plan. After the presentation, Ms. Hollis address any concerns and questions pertaining to project. Several questions we answered about restrictions and how the mural design would be approved. Fairfax Water required certain types of paint and has ultimate approval authority regarding the proposed mural. The Foundation and Gum Springs community stakeholders will decide on the mural design to present to Fairfax Water. Several other members of the community made statements regarding the process, but because of time limitations, were asked to present their statements in writing and/or at the next Council meeting.

Larry Zaragoza presented a Joint Resolution with P&Z, Transportation, and E&R Committee. The resolution was for a Proposed Ordinance Change Process that would make ordinance changes public and available for public review and comment before they are adopted. The resolution passed unanimously.

David Walker, Vice-President of the Belle Haven Civic Association (BHCA), presented his association's concerns about the County's plan for a sewer upgrade related to the Alexandria Crossing project, made necessary by the increase in residential density. A wooded buffer between Route 1 and the Belle Haven community had previously been deeded to the County to retain the buffer as green space. County now wants to encroach into the buffer to upgrade the sewer. The Association estimates that the County proposal will result in deforestation of 3.8 acers (20% of green space) and significantly reduce the buffer. BHCA wants the County to consider other alternatives for placement and have an arborist make recommendations to the County on how to better preserve the green space.

Updates on open projects:

2550/2560 Huntington Ave – A letter was sent from the P&Z committee to Supervisor Storck reminding him that MVCCA believes the second floor should remain residential. Supervisor Storck still wants 2nd floor retail or community center, which is inconsistent with they recommendations of the impacted communities and the P&Z committee.

IMP Building – Since our previous meeting, the Supervisor met with land use attorney and developer. The Supervisor questioned if residential is appropriate for the site and did not commit to raising the project priority in the County Comprehensive Plan.

Lukens Lane – The Lukens Lane development was held up by the County because the plan did not preserve enough trees. The developer resubmitted new plan for 11 homes single family homes and three out lots for tree preservation. This is one less home than the previous submission.

Fire Station – No new news.

Dear Supervisor Storck,

We understand that there have been discussions regarding a community center on the second floor of the apartment building proposed for 2550 Huntington Ave. As you know, the MVCCA and the SSPA Task Force members have argued repeatedly in public hearings that the second floor of this building should remain residential. The comprehensive plan for this building says, "second floor retail if feasible". It is our position and was the position of the SSPA Task Force that it is not feasible nor appropriate for retail or community service activities to be on the second floor of 2550 Huntington Ave. Continued argument by the County Staff that the second floor should include commercial (or now a community center) has only had the effect of delaying development of this property, an all too familiar scenario in our part of the county. Frankly, this kind of stalling has put the brakes on too many projects along the Richmond Highway Corridor, instead of promoting development as foreseen in the Comprehensive Plan.

The Huntington community already has a community center which is located 5751 Liberty Dr, Alexandria, VA 22303 which appears to be under-utilized. Furthermore, there are multiple vacant buildings and office spaces along Richmond Highway near Huntington, as well as a large recreation center currently being constructed on Beacon Hill Rd very close to Huntington Community, that could very easily serve as a community center.

We, therefore, ask that you push back against the county staff's advocacy for second floor retail or a community center at 2550 Huntington Ave. We need to get our development projects going again (like the booming construction next door in Alexandria and Arlington) rather than stopping them with unreasonable demands.

Hello Katherine and others.

This message is to clarify the use of E-Scooters and E-Bikes along the George Washington Memorial Parkway, which includes the Mount Vernon Trail. Our primary focus is preserving and managing the parkway's natural, historical, and recreational resources. This includes maintaining the Mount Vernon Trail for safe and enjoyable use by pedestrians and bicyclists, while protecting the area's natural beauty.

While we understand the concern about abandoned e-scooters and e-bikes, collecting and impounding them creates a substantial workload that diverts staff from other priorities. The Superintendent's Compendium does not allow their use on trails; however, it is incumbent upon the vendors to restrict their use. Furthermore, the licensing and permitting of these devices are handled by local municipalities like the City of Alexandria, District of Columbia, and Arlington County.

You can volunteer to assist by reporting abandoned e-scooters and e-bikes. Please contact the company and/or relevant local authority to ensure better compliance. We've included a list of common companies operating in the area with links to their reporting procedures:
