The meeting was called to order at 7:01 p.m. on December 18, 2024.

Minutes from November 2024 — approved as written by acclimation.

New MVCCA Budget Chair — James Perkins, Meetings starting in January 2025

Education — committee chair has a conflict tonight and did not attend; committee will be looking at school budget and boundary discussions coming in the next several months.

**E&R** — had meeting in December and guest from Park authority attended: discussed Quander Fairchild parks trail which is moving forward; will have questions on this, and they are beginning the work. Also, some members of the committee attended P&Z meeting; Paul Spring Stream Valley Park will be undergoing a stream restoration; the question that will be raised will be about invasive plants, and that will be an issue the committee will be exploring.

Air Quality Monitoring - notice from Supervisor Storck's office that there is an interest in air quality monitoring previous air monitoring stations were shut down and now they are reviewing the potential future monitoring.

Recommendation to have someone come to one of the E&R meetings to talk about this potential issue.

**P&Z** — Meeting on December 2nd; discussed IMP building—8850 Richmond Hwy (20 percent occupied). Woodlawn historic overlay district guidelines are the biggest hurdle. Another discussion involved visitors to talk about the Barn at Grist Mill and dispel some of the rumors about what the project is and is not. They have not talked to the county yet, so not much to share. Concern how to maintain history and keep it a safe as possible. Barn is walking distance to several thousand homes.

**Public Safety** — Two speakers for the meeting in December, First was from Dept of Emergency Management and Security who stressed the need for community level emergency preparedness. Updated visit from NPS on parkway speed enforcement, with legislative efforts continuing to try and redirect money. There was an expression of interest to restrict turns at certain intersections but no specifics. Letter from Congressperson Byer to encourage enforcement. Looking to bring a speaker or crime statistics for January meeting.

**Transportation** — did not meet this month; Jason is stepping down as Transportation chair; board has someone who is interested and will be interviewing with the co-chairs and should be in place by January. Jason has been leading for about 4 years and believes it is time to step down and have someone else step up.

**SFDC** — Brief overview meeting December 18, and they are concentrating on helping Fairfax County to get EIP extended to get more tax breaks for businesses along the corridor; starting to go in with new murals painted on cloth on fencing along Richmond HWY to look better and more inviting.

Fairfax Federation — no meeting in December; Jan 23 7pm meeting Mateo Dunne will be giving a presentation on school boundary situation at Gatehouse Road FCPS building in the first floor cafeteria

**Stormwater** — Meetings starting back up in January with a focus on the budget and if priorities are included in the budget. Will be working with the new budget chair.

**Steering Committee** — has not set a new date to get together to discuss property around Sherwood Hall Library/ Police/Fire. Katherine shared some material from 2009 when the MVCCA made recommendations about that corner, and it mirrors a bit what it looks like in the future.

**Treasurer Report** — No income in November; two small expenses of \$168 for a second Zoom license and 2 months of MVCCA Record work. Treasurer report approved as published.

**Co-chair** — Two people from the board are on the nominating committee, and we need one more volunteer; we need to elect one more co-chair; Leo/Larry currently volunteering for this position; Karen's last MVCCA Record is complete, and Terry is now stepping in going forward for January.

#### **Supervisor Stork**

Newsletter and Good News Advisor/MVCCA Land Use has been sent.

Holiday open house Dec 4; food drive—about 60 bags worth of food were donated and will help about 30 families.

Mt Vernon first hike of the year—starting at Collingwood Park to Mt Vernon trail: 10 a.m. on January 1.

Little Hunting Creek—gravity sewer line was replaced a few years ago, and crews are now going to be working on the next phase; want the community to be aware of the impact of the work; met with Wessynton Community. Impact should be minimal.

Bus Rapid Transit Line — stations have different themes, and we are looking at designs; feedback was generally positive.

Parking Enforcement Increased—stepped up enforcement including tax administration enforcement for out-of-state plates.

# MVCCA 2025 E&R and P&Z Joint Meeting (01/02/2025)

E&R Chair, Larry Zaragoza and P&Z Chair Bindu Mathur convened the Zoom meeting at 7:00 p.m. on

January 2. Co-Chairs Katherine Ward and Scott Taylor were in attendance.

E&R communities represented included: Bell Haven Terrace Civic Association, Hollin Hall Village Citizens Association, Belle View Condominium Unit Owners Association, Tauxemount Community Association, Inc., Spring Bank Community Association, and Potomac Valley-River Bend Civic Association.

P&Z communities represented included: Belle Haven Terrace Association, CA of Hollin Hills, Collingwood Springs CA, New Gum Springs CA, Riverwood HOA, Spring Bank CA, and Wellington CA.

**Northern Virginia Soil and Water Conservation District** Scott Cameron, Chair of the Northern Virginia Soil and Water Conservation District discussed the district's work, including its involvement in discussions about invasive species management, renewable energy, and utility-scale solar. He also mentioned the district's operation of nine grant programs in Fairfax County, funded by both the county government and the Department of Conservation Recreation. He also discussed the need for a \$500,000 budget increase to address the dam safety issue at the Lake Barcroft Dam, which is structurally sound but not designed to handle the current frequency of storms and hurricanes. Katherine asked about the potential for agrivoltaics in Fairfax County, to which Scott responded that while there are some examples in Virginia, more awareness and education are needed for farmers and local planning commissions.

Resolution on the Plan Forward Industry "White Paper" Larry described the draft resolution distributed in advance of the meeting. He then motioned approval of the resolution, including minor edits made during the meeting. Poul seconded the motion and the motion was approved.

### Legislative Recommendations

Larry motioned to support the State personal income tax credit recommendation, which was seconded by Poul. The majority voted in favor of the item. Larry then moved to adopt the rest of the items as written and edited, which was seconded by Nandini. The majority voted in favor of this motion.

### Follow-up items

- Scott Cameron to engage with the E&R Committee during the Northern Virginia Soil and Water Conservation District's strategic plan revision process this winter.
- E&R Committee members to check the Friends of Dyke Marsh website for information on the annual water quality testing event in Mount Vernon Park.

Larry expressed his appreciation for the group's contributions and wished them a great New Year. The conversation ended with a motion to adjourn that was made, seconded and passed.

# MVCCA Transportation Committee Minutes January 13, 2025

The Mount Vernon Council of Citizens' Association (MVCCA) Transportation Committee met on January 13, 2025 in a virtual gathering hosted on Zoom. Participating in the meeting from the MVCCA was Jason Zaragoza, Transportation Committee Chair and attendance/note-taker for tonight's meeting.

### **ANNOUNCEMENTS**

- Prior to the holiday break Chairman Zaragoza notified the committee by email that he intends to step down as Chairman in 2025. He will begin searching for someone to take his place and urged committee members to consider stepping up to lead the committee.
- 2. Over the holiday break the National Park Service (NPS) named Jennifer Madello as the new Superintendent of the George Washington Memorial Parkway (GWMP). A link was also included: https:// www.nps.gov/gwmp/learn/news/jennifer-madelloselected-as-superintendent-of-george-washingtonmemorial-parkway-12-19-2024.htm. Chairman Zaragoza indicated that either he or his upcoming relief would invite Superintendent Madello to address the Committee at some later date.
- Reminder that there will be an in-person public meeting about the Richmond Highway Bus Rapid Transit (BRT) project which now has an expected completion date of 2033. The meeting will take place at 7:00 p.m. on January 15 at the Gerry Hyland Government Center (8350 Richmond Hwy). A flyer was also attached.

### AGENDA ITEMS

### **Transportation Priorities for 2025**

#### **Discussion**

Chairman Zaragoza started the discussion by noting that for most of the past 2 years the Committee has focused its energy on issues related to the George Washington Memorial Parkway, most notably speeding enforcement and improvements to the intersections of Belle View Blvd. and Belle Haven Road. The Committee's efforts were often frustrated by the fact that the GWMP is overseen by the National Park Service which operates within a large federal bureaucracy.

He suggested that there are other areas in the Mount Vernon District where the Committee could have more direct impact. These include areas under the jurisdiction of Fairfax County where the MVCCA has strong relationships with Supervisor Dan Storck's office and other county officials. He then opened the floor to members.

- The first member to speak suggested that the Committee advocate for the implementation of changes recommended by the ActiveFairfax Transportation Plan, which envisions a comprehensive network of "safe, comfortable, and convenient" transportation options to include trails for pedestrians and bicyclists. Chairman Zaragoza said this project aligns with the MVCCA's longrange vision for the Mount Vernon District and that the next step would be for the Committee to push for funding to implement the recommendations outlined in the plan.
- Another member cited the upcoming meeting regarding the Richmond Highway Bus Rapid Transit (BRT) Project and said that it's unclear if the final design has been determined or if there will be future opportunities for public input as the project unfolds over the next 8 years. Another member cited concern about the impact of overflow traffic to Fort Hunt Road and other smaller streets surrounding Richmond Highway as a result of the project. Chairman Zaragoza said that either he or his successor will invite project representatives to a future Committee meeting so that these questions can be answered.
- A member suggested that future efforts to improve safety on GWMP should focus on the intersections of Belle Haven Road, Belle View Blvd, and Morningside Lane.
- A member cited poor integration of the district's bus network with neighboring jurisdictions and the Metro System. Moreover, there was discussion on whether the Committee should advocate for extension of the Yellow Line to Fort Belvoir. Another member noted that Washington Metropolitan Area Transit Authority and local authorities are also exploring extending the Blue Line to Maryland instead of expanding the Yellow Line. All agreed the Committee should remain actively involved on the issue.
- A member asked if there has been any strategic planning for a potential move by the FBI to Springfield and the traffic issues that would result. Another member cited the need for comprehensive modeling which can predict where traffic will flow as the result of specific changes.
- Chairman Zaragoza noted that final recommendations for the I-495 Southside Express Lane Study will likely be made in 2025 and that the Committee should remain actively involved.
- Another member cited the need for additional public education on crosswalk laws to include increased visibility and signage to encourage drivers to stop for pedestrians. There was also a discussion on

various methods for traffic calming to enhance pedestrian safety.

Before discussion concluded, a member noted that State Senator Scott Surovell will hold a Mount Vernon Legislative Town Hall on at 9:00 a.m. Saturday, February 1, 2025 at Walt Whitman Middle School where some of these issues may surface.

### **Meeting Adjourned**

Chairman Zaragoza thanked members for their input regarding 2025 Transportation Committee focus items. The MVCCA Transportation Committee meeting concluded at 7:54 p.m.

# **Requires General Council Ratification**

### **MVCCA Legislative Recommendations for 2025**

### Support for solar energy:

- Establishing a nonrefundable income tax credit. For example, Del Krizek introduced HB 197 in the 2024 session to provide a state personal income tax credit for residential solar installation. Our nearby neighbor, South Carolina, has had such a credit for several years.
- Solar on buildings is important so that we can reduce our dependence on fossil fuels and also reduce the use of forests and prime agricultural lands for utility-scale solar farms. We anticipate that Delegate Bulova will be introducing a bill to empower county governments to promote appropriate solar energy, such as rooftops and parking lots, during the development process.
- Remove barriers to solar. Such solutions would include providing for cost-sharing of the interconnection of private solar energy generation to the electrical grid. Such costs should be allocated so that the solar installer pays for the costs of equipment for safety and reliability purposes at the premises of installation. The utility should bear the cost of needed equipment between the solar premises and the utility's generation facilities. The utility would recover its costs from its rate structure as the state Corporation Commission determines to be appropriate.
- Support legislation to allow local governments to establish efficient energy standards that differ from Virginia state code.
- Support legislation to authorize local jurisdictions to require commercial buildings to report publicly the energy use intensity of their buildings (benchmarking) and develop and enforce building energy performance requirements.

### **Data Centers**

- Support legislation to modify the Virginia Clean Economy Act to count renewable energy generated outside of Virginia's borders. The exceptional concentration of data centers in Virginia, especially Northern Virginia, has placed a strain on the electrical grid, and the resulting high energy demand is threatening Virginia's ability to meet carbon neutrality goals.
- Given the high energy demands and potential water demands that would threaten Northern Virginia water security (i.e., the ability of the region to deliver water to customers), data centers should be rewarded for sharing information on energy use, water use, and wastewater, including salts and PFAS (perand polyfluoroalkyl substances), if any, released to the publicly owned treatment facilities, especially wastewater released to the Upper Occoquan Service Authority. PFAS has been used in at least some

- systems that use liquid cooling for data center chips, so if wastewater includes PFAS, the PFAS should be removed before release to wastewater treatment facilities.
- Reward the major corporations and data center operators that share their data on energy use, water use, and wastewater (e.g., amount, constituents).
   Many of the major corporations that use data centers have goals that include net zero carbon, and these corporations should be thanked and rewarded for their environmental contributions, which may be shared nationally with shareholders but do not seem to be shared at the local level here in Virginia.

#### **Invasive Plants**

 Support legislation to label and highlight native plant species in nurseries and other places where plants are sold.

### **Chesapeake Bay and Living Shorelines**

- Provide legislation to ensure that property owners who legally raise the height of their bulkhead to protect their property from sea level rise can also raise the height of the land on the landward side of the bulkhead.
- Require objectivity from Wetland Boards, who have exceptional latitude to require replacement of manmade hardened structures with living shorelines at the expense of the property owner, which also devalues the property and reduces its use by the property owner.
- Under the Chesapeake Bay Preservation Act, a tidal waterfront property owner can be penalized for the removal of a single "wetland" plant. Yet "wetland" plants listed in Virginia law include plants that do not require a wetland environment. This is especially troubling as county, VDOT, and utility projects clearcut and regrade areas. The current law has been written and interpreted to be excessively stringent for property owners who have acquired and maintained their property in accordance with the law, which makes the law easy to enforce but lacks reasonableness. Virginia is a buyer-beware state, and the information for a property owner to make informed decisions, especially for tidal waterfront properties, is lacking.
- If living shorelines are really a priority, grants to support property owners who consider their property to be a viable option should be provided. The current amount of up to \$30,000 per property will be inadequate for most properties because engineering analyses and other costs will be needed so that the stability of the land and nearby structures will not be threatened. Moreover, much more funding will be needed to provide these grants because their budget would only allow for a few of these projects.
