Subject: Letter of Support for George Washington Memorial Parkway NPF Grant Application

We are writing to express our strong support for the George Washington Memorial Parkway's application for the National Park Foundation's Circular Economy Grant Program.

The George Washington Memorial Parkway will use these funds to replace outdated water fountains along the Mount Vernon Trail between Theodore Roosevelt Island and George Washington's Mount Vernon and near comfort stations with new, year-round, accessible and freeze-resistant models, offering significant benefits including the following:

- Improved trail user experience: Providing clean and reliable access to water throughout the year for trail users, including those living in nearby gateway communities;
- Environmental sustainability: Encouraging reusable water bottles and reducing plastic waste like single-use plastic bottles within the park, major components of the trash we collect during cleanups; and
- **Community engagement:** Promoting environmental stewardship and education about responsible waste management practices and the need to reduce harmful plastic waste in the environment.
